
- · Conformity to the booking in procedure

Directions and Arrival

From A14 - Exit A14 at junction and join the A45 heading West towards Wellingborough and Northampton. Travel for 11 miles and exit at the A409 (Tesco Roundabout). Take the second exit at the roundabout and go under the A45 and enter roundabout. Take the third exit on the roundabout and re enter the A45 heading East. Follow the A45 for ¾ of a mile and exit left onto Claudius Way. Kuehne-Nagel is the third building on the left. The visitors car park is located at the end of the building.

From M1 - Exit the M1 at junction 15 and join the A508 heading towards Wellingborough and Northampton. After 2 miles the road name changes to A45 from which travel a further 10 miles. At roundabout take the third exit remaining on the A45. After 2 miles exit left onto Claudius Way. Kuehne-Nagel is the third building on the left. The visitor's car park is located at the end of the building.
